They will also need to wipe down the sound system or any other areas which they have touched.

CITYMOVES RESIDENCY ARTIST GUIDELINES FOR USING THE SCHOOLHILL STUDIO FROM W/C 1st February 2022

We will be opening the Schoolhill studio at this point for only a small number of staff, small residencies and events/workshops.

Artists will have access to the studio from 10am to 4pm Monday to Sunday for the one week of their residency. These core hours can change in consultation with staff.

PLEASE READ AND SIGN TO CONFIRM THAT YOU HAVE READ THE RISK ASSESSMENT AND THE GUIDANCE BELOW

- 1 No artist/participant should come to the building if they are experiencing any symptoms of Covid 19 (high fever, persistent cough, loss of taste or smell), or indeed if they are feeling unwell in a way which could make people feel uncomfortable
- 2 On entering the studio, artists/participants should wash their hands or use hand sanitiser, and again when leaving, and regularly throughout the day
- 3 Only artists stated on the residency application should be in the studio, with no invited guests, unless otherwise approved by Citymoves Manager.
- 4 Artists/participants are responsible for maintaining the social distancing guidelines, as legislated by the Scottish Government (currently 1 metre)
- 5 All artists who come to the studio should bring their own crockery and cutlery. It is their responsibility to wash and clean these items, and they should not be shared.
- A deep clean of the studios will have been carried out prior to us resuming residency placements, and a thorough cleaning regime will be in place with our cleaning contractor to Covid 19 standards
- 7 Hands to be washed before and after use of toilets, and only one person in each of the toilet blocks at any time
- Artists must adhere to the times allotted to them (10am to 4pm or another time agreed in advance with staff) and not enter the studios out with those times, to ensure that our cleaning regime can be carried out
- 9 Any change in times stated above must be approved by a Citymoves manager
- 10 Cleaning spray and cloths and a hand sanitiser will be made available in the studio
- 11 Cleaning spray and cloths and hand sanitiser will also be available at the reception area, beside the kettle/microwave and in the kitchen area in the Dissection Room and in the toilets
- 12 Any Citymoves equipment which is used during a residency must be wiped down after use by artists where possible, using the cleaning materials provided. This includes the sound system, ballet barres, mats, blocks etc
- 13 Contact numbers for Citymoves staff will be provided. If a member of staff plans to visit Schoolhill studio, they will pre-arrange with the artist to ensure social distancing kept in place. Similarly, if an artist wishes to come to Anatomy Rooms from Schoolhill, they should pre-arrange this with staff.
